(the undersigned), hereinafter referred to as "Contractor," and San Diego Field Hockey Officials Association, hereinafter referred to as "S.D.F.H.O.A.," agree to the following:

1. Contractor is a sole proprietor, and is solely responsible for the payment of all taxes, judgments and liabilities the Contractor accrues. Contractor is solely responsible for the collection of fees due.
2. Contractor shall abide by the current Constitution and By Laws, Policies, Rules and Regulations, Ethical Standards, and Requirements of S.D.F.H.O.A..
3. Contractor shall provide officiating services to teams, schools and leagues, as assigned by S.D.F.H.O.A., for the fees arranged by S.D.F.H.O.A. Contractor shall, at the Contractor's option, have the right to reject any or all games assigned, without penalty; any accepted assignment that is turned back within 72 hours of the scheduled game time may be assessed a fee by the assigner.
4. S.D.F.H.O.A. shall not guarantee game assignments to any Contractor.
5. Contractor shall pay a "per game" assigning fee, as determined prior to the start of each season by the S.D.F.H.O.A. Board of Directors, to the contracted Assigner.
6. S.D.F.H.O.A. shall not provide Worker's Compensation, nor Health or Liability Insurance for Contractor. Contractor shall provide to S.D.F.H.O.A. written evidence of liability insurance in his/her name, in an amount of at least one million dollars (\$1,000,000.00).
7. Contractor shall indemnify and hold harmless the Association and its Officers. Contractor is solely responsible for Contractor's actions in route to and from, and while at, all meeting and assignment sites.
8. Contractor shall acquire such equipment and training, at Contractor's expense, as necessary for Contractor to adequately discharge the assignments arranged by S.D.F.H.O.A.
